SUBJECT: Revenue Sharing – Koinonia Foster Homes, Inc., Homes for Teens

ACTION REQUESTED

Approve appropriation of \$3,500 in Revenue Sharing monies to Koinonia Foster Homes, Inc., Homes for Teens as requested by Supervisor Gore (\$1,000), Supervisor Weygandt (\$500), Supervisor Holmes (\$1,000), Supervisor Jones (\$500) and Supervisor Gustafson (\$500).

BACKGROUND

In approving the following contributions, the Placer County Board of Supervisors finds that each and every approved contribution serves a public purpose by promoting the general welfare of the County and its inhabitants, therefore a benefit results to the County.

The Board of Supervisors is being asked to approve appropriations to Koinonia Foster Homes, Inc., Homes for Teens. Koinonia Homes for Teens provide full-scope residential mental health and SUD treatment for adolescent foster youth. The Koinonia Community School provides quality high school education for this at-risk population. For over 20 years the Koinonia Community School has been a key component of the treatment milieu. On June 30, 2021, the Placer County Office of Education will end its commitment to the Koinonia Community School and any equipment currently provided by the county will be removed from the classroom. With the passage of COVID-19's AB1505, there will be limited funds to offer alternative educational providers. Revenue Share contributions will be used to help offset the cost of classroom technical equipment.
