ACTION REQUESTED

Approve the reappointments of Robert Bradley to Seat #1 and Dan Cook to Seat #2 of the Sheridan Municipal Advisory Council as requested by Supervisor Weygandt.

BACKGROUND

The purpose of the Sheridan Municipal Advisory Council (MAC) is to advise the Board of Supervisors on matters specifically referred to it by the Board of Supervisors for review and recommendation, and on matters of concern that relate to the area served by the MAC. The MAC is composed of five members, with each member nominated by the Supervisor representing District Two and appointed by a majority of the Board of Supervisors. Each member serves a two-year term and members shall, at the time of appointment and at all times during term of office, be residents, property owners of real property, or business owners or managers operating a business within the MAC boundaries. Meetings are held on the second Wednesday of every other month at 7:00 p.m. at Stewart Hall, 6005 Camp Far West Road, Sheridan.
