**ACTION REQUESTED**

Approve appropriation of \$4,000 in Revenue Sharing monies to The Gathering Inn as requested by Supervisor Gore (\$1,000), Supervisor Weygandt (\$500), Supervisor Holmes (\$1,000), Supervisor Jones (\$500) and Supervisor Gustafson (\$1,000).

**BACKGROUND**

In approving the following contributions, the Placer County Board of Supervisors finds that each and every approved contribution serves a public purpose by promoting the general welfare of the County and its inhabitants, therefore a benefit results to the County.

The Board of Supervisors is being asked to approve appropriations to help offset the costs of Gathering for Hope 2021, an annual fundraising event hosted by The Gathering Inn. The vision of The Gathering Inn is to end homelessness in the community by offering comprehensive services to homeless men, women and children, addressing mental health issues, addiction, employment needs, medical and dental care, and basic needs. The goal of the organization is to help homeless individuals in the community achieve housing. Revenue Share contributions will be used to help defray the costs of food and supplies for this year's Gathering for Hope event.
