

CONTRACT AMENDMENT

Description: Third amendment to this contract between North Valley Behavioral Health, LLC, a limited liability company, hereinafter referred to as "CONTRACTOR" and the County of Placer, hereinafter referred to as "COUNTY," to increase compensation by \$474,000 for a revised total of \$1,800,000 to cover increased expenditures listed in Section 3.

WHEREAS, COUNTY has been charged with the responsibility of providing mental health services for mentally disordered persons in Placer County, and

WHEREAS, CONTRACTOR operates a licensed sixteen-bed psychiatric health facility (PHF) staffed to provide acute psychiatric inpatient care and maintenance for mentally disordered persons, and has agreed to provide services to assist in this venture as outlined below, and

WHEREAS, it is necessary to modify the current agreement to **further** increase compensation to correspond with the demand for these services, and

WHEREAS, it is understood and agreed by and between the parties of this Agreement that they wish to enter into this Agreement in order to provide a full and complete statement of their respective responsibilities in connection with this venture during the term of this Agreement, and

NOW, THEREFORE, IT IS AGREED BY BOTH PARTIES THAT, EFFECTIVE July 1, 2020, the following amendment is made to the original contract, additions are shown in bold italics, deletions are shown in strike-through:

3. **PAYMENT:** COUNTY will pay to CONTRACTOR as full payment for all services rendered pursuant to this Agreement in the amount set forth in Exhibit B-1, titled Payment Provisions. The payment specified in Exhibit B-1 shall be the only payment made to CONTRACTOR for services rendered pursuant to this Agreement. The total amount of this contract and payments made under this Agreement shall not exceed ~~ONE MILLION THREE HUNDRED TWENTY SIX THOUSAND AND 00/100 DOLLARS (\$1,326,000)~~ **ONE MILLION EIGHT HUNDRED THOUSAND DOLLARS (\$1,800,000)**. This rate shall be inclusive of all CONTRACTOR costs, including, but not limited to travel, transportation, lodging, meals, supplies, and incidental expenses except as otherwise might be specifically set forth in this Agreement. CONTRACTOR shall charge for travel according to the Federal General Services Administration (GSA) guidelines.
