**ACTION REQUESTED**

Approve appropriation of \$3,250 in Revenue Sharing monies to Campus Life Connection as requested by Supervisor Gore (\$1,500), Supervisor Weygandt (\$250) and Supervisor Jones (\$1,500).

**BACKGROUND**

In approving the following contributions, the Placer County Board of Supervisors finds that each and every approved contribution serves a public purpose by promoting the general welfare of the county and its inhabitants, therefore a benefit results to the county.

For nearly 30 years Campus Life Connection (CLC) has served thousands of teens and families throughout the region, offering programs such as Point Break, which develops character, confidence and responsibility in young people's lives. Point Break's evidence-based workshops make schools more accepting places and have proven to increase empathy, which decreases bullying and harassment and unifies students, regardless of socioeconomic status. Funds will be used to offset the costs of this year's Point Break program and the annual Roseville Celebrity Chili Cook-Off fundraiser.

This year's fund-raiser, featuring more than two dozen prominent Roseville-area leaders as chili chefs, will help more Placer County schools have workshops.
