ACTION REQUESTED

Approve appropriation of \$3,175 in Revenue Sharing monies to Kids First as requested by Supervisor Gore (\$1,000), Supervisor Weygandt (\$250), Supervisor Holmes (\$325), Supervisor Jones (\$1,500) and Supervisor Gustafson (\$100).

BACKGROUND

In approving the following contributions, the Placer County Board of Supervisors finds that each and every approved contribution serves a public purpose by promoting the general welfare of the county and its inhabitants, therefore a benefit results to the county.

The Board of Supervisors is being asked to approve Revenue Sharing funds for KidsFirst for its Putting Kids First Golf Tournament fundraiser. KidsFirst serves as Placer County's Child Abuse Prevention Council and provides a variety of services and support programs to families in Placer County including emergency housing, financial assistance, parenting classes, childcare and therapeutic services for children and adults. Revenue sharing contributions will be used to offset costs associated with hosting the golf tournament.
