**ACTION REQUESTED**

Approve appropriation of \$2,850 in Revenue Sharing monies to Tommy Apostolos Fund as requested by Supervisor Gore (\$1,500) Supervisor Weygandt (\$500), Supervisor Jones (\$750) and Supervisor Gustafson (\$100).

**BACKGROUND**

In approving the following contributions, the Placer County Board of Supervisors finds that each and every approved contribution serves a public purpose by promoting the general welfare of the County and its inhabitants, therefore a benefit results to the County.

The Board of Supervisors is being asked to approve appropriations to help support the Tommy Apostolos Fund. In 1988, in memory of Tommy Apostolos, the Apostolos Family partnered with local agencies to take ten underprivileged children shopping. Now working in partnership with Kohl's, the organization has matched more than 500 children from Roseville and surrounding areas with more than 700 community volunteers to take underserved children shopping during the holidays. Each child receives approximately \$150 worth of essentials such as clothing, coats, shoes and other necessities. Revenue sharing contributions will be used to purchase clothing for the kids.

Describe the organization's purpose and/or mission and the people served.	The Tommy Apostolos Fund was established in 1988 in memory of Tommy Apostolos, a lifetime Roseville resident and a 30+year employee of Roseville Telephone Company. Originally, the Fund was a cooperative between the Roseville Telephone Company, the Roseville Police Association, and the Apostolos Family with a few support volunteers. Our first kid's shopping day in 1988 had just 10 kids. Today we provide over 500 children each year with much needed clothing, shoes, and essentials.
Briefly describe the program or the event for which you are requesting funds.	These funds will be totally used for shopping with the kids the first Saturday in December. We will take over 500 kids shopping at 4 am and provide them with essentials like pants, shirts, shoes and warm coats. We spend \$125 per child so that

morning we will spend over \$50,000 on the kids with a generous discount from Kohl's.

Briefly describe how these funds we will be utilized.      The funds will be used exclusively to buy clothing for the kids at Kohl's in Roseville. Children in need are identified by their teachers and we then take them shopping at Christmas time. We usually have over 800 volunteers assisting with the shopping.
