ACTION REQUESTED

Approve appropriation of \$2,475 in Revenue Sharing monies to Seniors First as requested by Supervisor Gore (\$1,000), Supervisor Weygandt (\$250), Supervisor Holmes (\$325), Supervisor Jones (\$750) and Supervisor Gustafson (\$150).

BACKGROUND

In approving the following contributions, the Placer County Board of Supervisors finds that each and every approved contribution serves a public purpose by promoting the general welfare of the county and its inhabitants, therefore a benefit results to the county.

The Board of Supervisors is being asked to approve appropriations to help support Seniors First, Meals on Wheels. Meals on Wheels provides a hot noon-time meal and safety check five days a week to seniors in Placer County who are homebound or immobile. Revenue Share contributions will be used to purchase food and offset additional costs of providing meals to seniors.
