**ACTION REQUESTED**

Approve appropriation of \$600 in Revenue Sharing monies to Placer County Council Navy League of the United States, Auburn Area Veterans Day Parade as requested by Supervisor Holmes (\$250), Supervisor Jones (\$100) and Supervisor Gustafson (\$250).

**BACKGROUND**

In approving the following contributions, the Placer County Board of Supervisors finds that each and every approved contribution serves a public purpose by promoting the general welfare of the County and its inhabitants, therefore a benefit results to the County.

The Board of Supervisors is being asked to approve an appropriation to Placer County Council Navy League of the United States to help support the Auburn Area Veteran's Day Parade. The parade offers the community an opportunity to show their support for local veterans in a positive and supportive venue. The event includes distributing 700 commemorative medals to be given out to veterans attending the parade, flags for spectators, printing of 1,000 programs and condiments for the free lunch after the parade. Any Revenue Sharing funds approved will be used to offset costs associated with hosting the event.
