BACKGROUND

The purpose of the Squaw Valley Design Review Committee is to assist the Planning Services Division and Planning Commission in matters of design within the area served by the Design Review Committee. All recommendations by the Committee shall be advisory only. The committee is comprised of five members who are residents of the Squaw Valley General Plan area. The members are appointed by the Board of Supervisors and serve two-year terms, however the first term for Seats #1 and #2 is one year, with two-year terms thereafter. The committee meets on the first Thursday of every month at the Squaw Valley Fire Department meeting/conference room.
