

I am writing to you regarding item 6 on the September 14, 2021 agenda. I had the pleasure of listening to a couple of representatives of the Deputy Sheriff's Association regarding your agenda item and Measure F.

It is my understanding that you as a board are attempting to subvert the will of the voters and impose a contract on the Sheriff's Deputies that is not based in law, but is based on your whim. The sheriffs have sworn an oath to uphold the constitution of the State of California and of the united states of America and inherent in upholding those foundational documents, they are responsible for protecting the property and rights of the citizens in their county. You as a committee have been elected by the people for the people.


My question for each of you is: What is the good for the people of Placer County in your efforts to adjust, minimize the pay schedule for the DSA?




