SUBJECT: Wastewater Advisory Committee

ACTION REQUESTED

Approve the reappointment of Ramzi J. Mahmood to Seat #2, representing Academia, Robin Mahoney to Seat #4, representing Facility Services, and David Slaughter to Seat #8, representing On-Site Sewage Disposal, on the Wastewater Advisory Committee.

BACKGROUND

The purpose of the Wastewater Advisory Committee is to make recommendations to the Environmental Health Director regarding ordinance adoption and revisions, review methods, techniques and materials for on-site sewage treatment and disposal, and policy issues. The committee is composed of (13) thirteen members, one representing each of the following: Placer County Architects, Geologists, Engineers, and Surveyors (P.A.G.E.S.); Academia; Placer County Assn. of Realtors; Placer County Facility Services; Septage Pumper; Septic Tank Manufacturers' Assn.; Building Industry; On-Site Sewage Disposal Consultant; Contractors/Installers' Assn.; Public-at-Large; Environmental Consultant; Planning Commissioner or member of the Board of Supervisors; and Manufacturers' Association (shall be appointed by the Board of Supervisors). Each member serves a two-year term and the committee shall meet at the call of the Chairperson.

Res. 2004-273 renaming the Sewage Disposal Advisory Committee to Wastewater Advisory Committee.

COMPOSITION: Composed of thirteen (13) members, one each representing the following: Placer County Architects, Geologists, Engineers, and Surveyors (P.A.G.E.S.); Academia; Placer County Association of Realtors; Placer County Department of Facility Services; Septage Pumper; Septic Tank Manufacturers Association; Building Industry; On-Site Sewage Disposal Consultant; Contractors/Installers' Association; Public-at-Large; Environmental Consultant; Planning Commissioner or Member of the Board of Supervisors; Manufacturers' Association (to be appointed by the Board of Supervisors). The term is for two years commencing on October 1, 2000. Per Res. 2004-273 members in Seats 1, 2, 3, 4, 8, and 13 shall terminate on 10/01/2005 and 2-year terms; members in Seats 5, 6, 7, 9, 10, 11, and 12 shall terminate on 10/01/06 and 2-year terms.

MEETINGS: The committee shall meet at the call of the chairperson.

COMPENSATION: Members shall receive no compensation for their services.
