ACTION REQUESTED

Approve appropriation of \$4,000 in Revenue Sharing monies to William Jessup University as requested by Supervisor Gore (\$1,000), Supervisor Weygandt (\$500), Supervisor Holmes (\$500), Supervisor Jones (\$1,500) and Supervisor Gustafson (\$500).

BACKGROUND

In approving the following contributions, the Placer County Board of Supervisors finds that each and every approved contribution serves a public purpose by promoting the general welfare of the County and its inhabitants, therefore a benefit results to the County.

William Jessup University is requesting Revenue Sharing funds to help support the annual President's Dinner event. As the only four-year private university in Placer County, William Jessup University has directly impacted the community by providing higher education in Placer County since 2004. This year's President's Dinner will be held on October 28th and will highlight the launch of the University's nursing program, which will benefit healthcare facilities and hospitals in our region. The event will also raise funds to help make higher education more accessible and affordable to all, and will be used to support student scholarships, mobile medical clinic and the nursing program. Revenue Sharing funds will be used in support of student scholarships.
