**ACTION REQUESTED**

Approve appropriation of \$1,150 in Revenue Sharing monies to The Forgotten Soldier Program, 111-Mile Fallen Heroes Motorcycle Ride as requested by Supervisor Weygandt (\$200), Supervisor Holmes (\$500), Supervisor Jones (\$250) and Supervisor Gustafson (\$200).

**BACKGROUND**

In approving the following contributions, the Placer County Board of Supervisors finds that each and every approved contribution serves a public purpose by promoting the general welfare of the County and its inhabitants, therefore a benefit results to the County.

The Board of Supervisors is being asked to approve appropriations to help support The Forgotten Soldier Program, an organization that helps veterans settle back into civilian life. For more than 12 years the Forgotten Soldier Program has helped 17,000 veterans and their family members by providing assistance to veterans who are referred by the Veterans Association and the Wounded Warrior program. The 111-Mile Fallen Heroes Motorcycle Ride is a fundraiser that invites participants to help honor fallen United States military personnel and raise awareness of issues faced by returning service members. In addition to the ride the event will also include a barbecue, live music and a raffle. Revenue Share contributions will be used to help offset the cost of the event, including the purchase of food and supplies.
