**ACTION REQUESTED**

Approve appropriation of \$2,200 in Revenue Sharing monies to Feed the Hungry of Auburn, Junior Livestock Auction, as requested by Supervisor Gore (\$250), Supervisor Weygandt (\$200), Supervisor Holmes (\$1,000), Supervisor Jones (\$250) and Supervisor Gustafson (\$500).

**BACKGROUND**

In approving the following contributions, the Placer County Board of Supervisors finds that each and every approved contribution serves a public purpose by promoting the general welfare of the County and its inhabitants, therefore a benefit results to the County.

The Board of Supervisors is being asked to approve an appropriation to help support Feed the Hungry of Auburn 2021 Junior Livestock Auction. Feed the Hungry of Auburn's purpose is to implement food rescue projects that link food sources to community food banks, ministries, shelters and kitchens to provide food for those most in need. Their mission has expanded to help support low-income families, single parent families and the organizations that provide services and support to them. Revenue Share funds will be used to help cover the cost of purchasing, processing and packaging livestock raised by members of local 4-H and Future Farmers of America groups that is then donated to community food closets for distribution to families in need.
