**ACTION REQUESTED**

Approve the appointment of Christopher Hill to the unexpired term of Seat #7 of the Granite Bay Municipal Advisory Council as requested by Supervisor Jones.

**BACKGROUND**

The purpose of the Granite Bay Municipal Advisory Council (MAC) is to advise the Board of Supervisors on matters specifically referred to it by the Board of Supervisors for review and recommendation, and on matters of concern which relate to the area served by the Council. The MAC shall adopt rules, regulations and procedures as are reasonable and appropriate for its activity, as are specifically approved by the Board of Supervisors. The Council is composed of seven members at-large, with each member nominated by the Supervisor representing District four and appointed by a majority of the Board of Supervisors. Each member serves a two-year term and members shall, at the time of appointment and at all times during term of office, be residents, property owners of real property, or business owners or managers operating a business within the MAC Boundaries. Failure to maintain such status shall result in a vacancy of office. Meetings are held on the first Wednesday of each month.
