**SUBJECT:** Amend Placer County Code Ch. 2 regarding Compensation and Reimbursement for Grand Jurors

---

**ACTION REQUESTED**

Introduce an Ordinance, waive oral reading, amending Chapter 2, Article 2.112, Section 2.112.060 of the Placer County Code to remove the daily limit for compensable committee or subcommittee meeting attendance for the Placer County Grand Jurors.

**BACKGROUND**

Chapter 2 of the Placer County Code provides regulations for compensation and reimbursement for grand jurors. Following a recent review of Section 2.112.060, the County Executive Office identified the need to update language related to the compensation for attendance by grand jurors at committee and subcommittee meetings. Current code states that the each member of the grand jury shall receive ten dollars (\$10.00) for attendance at each authorized committee or subcommittee meeting up to a limit of two meetings per day. In recognition that varied duties of the grand jury may require attendance of members at three or more meetings in a given day, the proposed ordinance removes the daily limit on compensable committee and subcommittee meetings for members of the grand jury.

**FISCAL IMPACT**

The proposed amendment to the County Code is not expected to result in any fiscal impact.

THE BOARD OF SUPERVISORS OF THE COUNTY OF PLACER, STATE OF CALIFORNIA,  
DOES HEREBY ORDAIN AS FOLLOWS:

**Section 1.** Placer County Code, Chapter 2, Article 2.116, Section 2.116.060, is hereby  
amended as follows:

2.112.060 Compensation and reimbursement for grand jurors.

A. Full Panel Meetings. Each member of the grand jury shall receive a maximum of  
twenty-five dollars (\$25.00) up to a total of two full panel meetings per month while sitting as a  
civil grand jury, and a maximum of twenty-five dollars (\$25.00) for each day in attendance while  
sitting as a criminal grand jury on indictments brought to the grand jury by the district attorney or  
the attorney general.

B. Committee Meetings. Each member of the grand jury shall receive ten dollars (\$10.00) for attendance at each authorized committee or subcommittee meeting ~~up to a limit of two meetings per day.~~

C. No member of the grand jury shall receive mileage reimbursement for miles traveled outside the county unless authorized in advance by the court executive officer or advising superior court judge.

D. Each member of the grand jury shall receive, for each mile actually traveled in attendance as a grand juror, reimbursement at the rate specified in Section 2.30(g) of the administrative rules. (Prior code § 2.2600)

**Section 2.** This ordinance shall take effect and be in full force thirty (30) days after the date of its passage. The Clerk is directed to publish this ordinance, or a summary thereof, within fifteen (15) days in accordance with Government Code Section 25124.
