**SUBJECT:** Multi-Use Dump Trucks - Riverview International Trucks

## **ACTION REQUESTED**

1. Approve a FY 2021-22 Budget Amendment (AM-00594) in the amount of \$76,766 to increase the Cost Center 19007 – Road Maintenance in the Equipment Ledger 54450 and reduce Cost Center 19007 – Road Maintenance in the Professional Services Ledger 52360 in the amount \$76,766.

- 2. Approve the award of a negotiated purchase order to Riverview International Trucks LLC of West Sacramento, CA utilizing the State of California Contract No. 1-18-23-20F for the purchase of two multi-use dump trucks in the total amount of \$557,026.
- 3. Authorize the Purchasing Manager to sign all required documents.

#### **BACKGROUND**

On August 31, 2021, the Board of Supervisors approved the purchase of various vehicles utilizing State of California awarded contracts and authorized the purchase of additional vehicles contingent upon the requests being appropriately budgeted. The Department of Public Works Roads Division (DPW) has identified two dump trucks that are nearing the end of their useful life and submitted a request to purchase two new multi-use dump trucks with accessories.

The department currently owns and operates the same brand of International Trucks and is very satisfied with the equipment's overall performance and durability. The International Truck, Model HV, will be equipped with a multi-use hookloader system, water tank, chipper body, and dump bed to allow the functionality to accomplish multiple road maintenance related activities including snow removal. These hookloader type systems will allow these trucks to get used all year long versus seasonal use.

On May 1, 2018, the State of California awarded contracts to various responsive bidders, including Riverview International, as the result of competitive request for proposal for fleet vehicles. The contract with Riverview International, Contract No.1-18-23-20 F, is effective through April 30, 2022 and allows local government agencies to use this contract without any additional cost to the local agencies. Riverview International provided a price quote for the purchase, under the terms of the State Contract No. 1-18-23-20 F, in the total amount of

\$557,026. Pricing includes the dump trucks, hookloader, hydraulics, water tank, chipper body, dump body, installation, applicable sales tax, and tire fees.

DPW and Procurement Services agree that purchasing the trucks from Riverview International using the State of California contract is a cost effective solution. Procurement Policy Section 3.5(A) permits contracting with a vendor that was awarded an agreement by a cooperative purchasing program as the result of a competitive process without further competitive bidding by Placer County. The State of California contract meets this criterion.

Therefore, your Board's approval is required to proceed with a purchase of two multi-use dump trucks in the amount of \$557,026 and authorize the Purchasing Manager to sign the resulting purchase order and related documents.

# **FISCAL IMPACT**

Funding for the multi-use trucks in the amount of \$557,026 is available within the Department of Public Works Roads Division FY 2021-22 Budget. A FY 2021-22 Budget Amendment (AM-00594) is required to move \$76,766 in expenditure authority from the professional services line item to the equipment line item in Cost Center 19007. The overall budget amount for Road Maintenance will not change. There is no additional impact to the County General Fund.
