**Fees: \$17 per copy for a "Public Marriage Certificate" - \$22 per copy for a "Confidential Marriage Certificate" (payable to the Placer County Clerk).** If no record of the marriage is found, the fee will be retained for searching the record (as required by law) and a "Certificate of No Record" will be issued to the applicant. #### PUBLIC MARRIAGE CERTIFICATE (Non-Confidential):

To receive an authorized certified copy, I am:

- The registrant (one of the parties to the marriage)
- A parent, legal guardian, child, grandparent, grandchild, sibling, spouse, or domestic partner of the registrant
- A party entitled to receive the record as a result of a court order
- A member of a law enforcement agency or a representative of another governmental agency, as provided by law, who is conducting official business
- An attorney representing the registrant or the registrant's estate, or any person or agency empowered by statute or appointed by a court to act on behalf of the registrant or the registrant's estate

Those who are not authorized by law to receive a certified copy of a public marriage record will receive a certified copy marked "INFORMATIONAL, NOT A VALID DOCUMENT TO ESTABLISH IDENTITY".
