**SUBJECT:** Adoption of an amended FY 21-22 Position Allocation Ordinance

---

**ACTION REQUESTED**

Adopt an Ordinance, introduced on February 22, 2022, approving an amended FY 21-22 Un-Codified Allocation of Positions to Departments (Attachment A).

**BACKGROUND**

The Board adopted the FY 2021-22 Un-Codified Allocation of Positions to Departments with the final budget adoption on June 22, 2021. The Allocation Ordinance was amended on November 30, 2021, and CEO is requesting additional changes today.

A total of twenty-three (23) funded allocations are being added along with reclassifications to existing allocations. The additions include five (5) allocations added to CDRA, three (3) for specific plan projects and two (2) to assist in the integration of new software. The Auditor-Controller is adding one (1) Accountant to aide in the increased workload due to increasing GASB requirements. Health and Human Services is increasing thirteen (13) funded allocations. Ten (10) are related to the significant increase in workload due to the COVID response and three (3) for increased administrative assignments. The Sheriff's Department is adding four (4) funded allocations, two (2) Deputy Sheriffs and two (2) Investigative Assistants to replace retired annuitants. The amended Un-codified Allocation of Positions to Departments is attached (Attachment A).
