**SUBJECT:** Building Forward: Library Infrastructure Grant Program

#### **ACTION REQUESTED**

Adopt a resolution authorizing the County Executive Officer or designee to execute and submit applications and related documents for the California State Library Building Forward: Library Infrastructure Grant Program.

#### **BACKGROUND**

The Budget Act of 2021 (SB129) allocated \$439 Million in one-time funds to the California State Library to address life-safety and critical maintenance needs of public library facilities throughout California. In February 2022 the California State Library released guidelines regarding its Building Forward: Library Infrastructure Grant Program. This grant program prioritizes funding for local libraries located in high poverty areas of the state. The maximum grant amount per library facility is \$10 Million with a dollar-for-dollar match requirement, and all projects related to this grant must be completed by March 2026.

Two libraries in the Placer County Library system that serve communities with the highest percent of population in poverty based on the California Poverty Measure (Source: California State Library, California Poverty Measure Data for Libraries https://www.library.ca.gov/grants/infrastructure/) are Auburn (19.87%) and Kings Beach (18.51%). Given the grant guidelines, Library Services intends to submit one application for critical infrastructure upgrades at the Auburn Library and another application for planning and acquisition, construction, or tenant upgrades for a Kings Beach Library location.

For the Kings Beach Library project, Library staff, along with staff from the County Executive Office, Facilities Management, and Economic Development are exploring location options including existing county-owned facilities, potential lease opportunities, and sites for possible construction of a new library. Given the ongoing library study is currently a work-in-progress, several potential sites will be considered. Consistent with the grant criteria, preliminary planning is also considering co-locating a library with ancillary community-serving uses, such as community meeting rooms which could serve as an emergency/fire evacuation site, a warming/cooling center, or a venue for community classes and/or events. Both applications will include the allowed 10% allocation towards grant administration.
