**ACTION REQUESTED**

Approve appropriation of \$3,750 in Revenue Sharing monies to Sierra College Foundation, A Taste of Excellence as requested by Supervisor Gore (\$1,000), Supervisor Weygandt (\$250), Supervisor Holmes (\$1,000), Supervisor Jones (\$500), and Supervisor Gustafson (\$1,000).

**BACKGROUND**

In approving the following contributions, the Placer County Board of Supervisors finds that each and every approved contribution serves a public purpose by promoting the general welfare of the County and its inhabitants, therefore a benefit results to the County.

The Board of Supervisors is being asked to approve appropriations to the Sierra College Foundation, Taste of Excellence fundraising event. The Sierra College Foundation is a non-profit organization formed in 1972 that provides the opportunity to invest in the quality education Sierra College offers to students at several campuses throughout Placer County. The Taste of Excellence event raises funds to support student programs such as the Student Assistance Fund Endowment (SAFE) which helps defray the cost of living so that students can stay in school and be successful in achieving their higher education goals. Revenue Sharing funds will be used to help offset the costs associated with the event.
