ACTION REQUESTED

Approve appropriation of \$4,000 in Revenue Sharing monies to Lighthouse Counseling and Family Resource Center, Celebrity Waiter Luncheon as requested by Supervisor Gore (\$500), Supervisor Weygandt (\$2,000), Supervisor Holmes (\$500), Supervisor Jones (\$750), and Supervisor Gustafson (\$250).

BACKGROUND

In approving the following contributions, the Placer County Board of Supervisors finds that each and every approved contribution serves a public purpose by promoting the general welfare of the County and its inhabitants, therefore a benefit results to the County.

The Board of Supervisors is being asked to approve appropriations to Lighthouse Counseling and Family Resource Center. Lighthouse Counseling and Family Resource Center helps to build healthy families and communities by providing full-service counseling and family resources. The organization provides parenting, co-parenting and other educational programs designed to assist at-risk, low-income families in Placer County. Their Celebrity Waiter Luncheon fundraising event will be held on May 13, 2022. Revenue share funds will be used to help offset the cost of the event.
