ACTION REQUESTED

Approve appropriation of \$2,000 in Revenue Sharing monies to Sierra College Foundation, Guardian Scholar Program as requested by Supervisor Weygandt (\$500), Supervisor Holmes (\$500), Supervisor Jones (\$500), and Supervisor Gustafson (\$500).

BACKGROUND

In approving the following contributions, the Placer County Board of Supervisors finds that each and every approved contribution serves a public purpose by promoting the general welfare of the county and its inhabitants, therefore a benefits results to the county.

The Board of Supervisors is being asked to approve appropriations to the Sierra College Foundation, Guardian Scholars Program. The Sierra College Foundation is a non-profit organization formed in 1972 that provides the opportunity to invest in the quality education Sierra College offers to students at several campuses throughout Placer County. The Guardian Scholar Program provides services to current or former foster youth (FFY) attending Sierra College. The goal is to equip and empower students to do well academically and also navigate life and financial challenges that can be barriers to their success. The Guardian Scholar Program assists former foster youth students at Sierra College with housing, mental health care, food and hygiene necessities. Revenue Share contributions will be used to help offset the costs of the program.

FISCAL IMPACT

Funding is provided for in the FY 2021-22 Board of Supervisors budget (CC10002). There is no additional impact to the general fund.
