**ACTION REQUESTED**

Approve appropriation of \$1,500 in Revenue Sharing monies to the South Placer Heritage Foundation as requested by Supervisor Gore (\$250), Supervisor Holmes (\$1,000), and Supervisor Jones (\$250).

**BACKGROUND**

In approving the following contributions, the Placer County Board of Supervisors finds that each and every approved contribution serves a public purpose by promoting the general welfare of the county and its inhabitants, therefore a benefits results to the county.

The Board of Supervisors is being asked to approve appropriations to the South Placer Heritage Foundation. The South Placer Heritage Foundation was founded in 1995 by a group of citizens in the Loomis area for the purpose of renovating the remaining fruit sheds in the area. The Foundation has successfully renovated the 77 year old Blue Goose Fruit Packing Shed for use as a community gathering place for meetings, social events and concerts. These types of events help reinforce the strong social fabric of South Placer County. Revenue Share contributions will be used to help offset the costs of maintaining the building through the purchase of supplies and materials.

Funding is provided for in the FY 2021-22 Board of Supervisors budget (CC10002). There is no additional impact to the general fund.
