ACTION REQUESTED

Approve appropriation of \$675 in Revenue Sharing monies to the Auburn Host Lions Club, Charity Golf Tournament as requested by Supervisor Holmes (\$250), Supervisor Jones (\$250), and Supervisor Gustafson (\$175).

BACKGROUND

In approving the following contributions, the Placer County Board of Supervisors finds that each and every approved contribution serves a public purpose by promoting the general welfare of the county and its inhabitants, therefore a benefits results to the county.

The Board of Supervisors is being asked to approve appropriations to the Auburn Host Lions Club to help fund their annual charity golf event. The Auburn Host Lions Club members volunteer their time, money, and labor to nonprofit organizations and programs within the community. This year the money raised from the charity golf event will allow the Lions Club to continue to support local charities and scholarships.
