SUBJECT: Umbrella Contract Psychological Evaluation Services

ACTION REQUESTED

Authorize an umbrella agreement for the provision of psychological evaluation services by an identified list of providers from September 1, 2022 through August 31, 2023, in an amount not to exceed \$150,000; approve the provider list and authorize the Director of Health and Human Services, or designee, to amend the list of providers as necessary so long as amendments are included in the following years' list; and authorize the Director of Health and Human Services, or designee, to execute any needed provider agreements, amendments, or other documents utilizing applicable County processes with Risk Management and County Counsel concurrence.

BACKGROUND

Psychological evaluations are periodically ordered in Child Welfare judicial proceedings to identify which services would be helpful for the parent to safely parent their child(ren) again, or to determine if a parent is able to benefit from services to safely parent their child(ren) again.

In addition, psychological evaluations are occasionally necessary to thoroughly assess youth who present with complex behavioral health needs.

Approval of this contract and funding will allow the Children's System of Care increased flexibility to engage multiple providers and ensure timely reports to meet the requirements of the court and promote child safety and permanency for Child Welfare dependents or create comprehensive treatment plans for youth with complex behavioral health needs.

FISCAL IMPACT

Total expenditures under this contract are \$150,000 and are included in the Department's FY 2022-23 Budget. Funding for this contract consists of \$55,500 (37%) in State Funds, \$79,500 (53%) in Federal Funds and \$15,000 (10%) in County General Funds.
