SUBJECT: Delinquent Garbage Collection Bills for Franchise Area 3 / Authorize Auditor to Place on the Tax Roll

ACTION REQUESTED

Adopt a Resolution authorizing and directing the County Auditor to place delinquent Solid Waste Franchise Area 3 garbage collection bills on the FY 2022-23 County Tax Roll in an amount up to \$219,817.67 which includes a \$40 per account administrative fee.

BACKGROUND

This is an annual action taken to recover unpaid fees for solid waste collection services. Garbage collection service is mandatory in Solid Waste Franchise Area 3 (Tahoe) pursuant to County Code Section 8.16.220 in compliance with the Goals and Policies of the Tahoe Regional Planning Agency's Regional Plan for the Lake Tahoe Basin. The County is contractually obligated to pay the Franchisee, Tahoe Truckee Sierra Disposal Co., Inc. (TTSD) for any customer billings that are more than 60 days delinquent as of March 31st of each year. The County recovers the balance of the unpaid accounts through annual property tax billing. In addition, your Board has historically approved the assessment of a \$40 per account administrative fee to cover the County's costs associated with collecting the unpaid bills.

TTSD has identified 412 unpaid accounts totaling \$205,497.88. Of this amount, 14 accounts, totaling \$1,600.21, have been identified as uncollectable through the County Tax Roll due to changes in property ownership; the County is responsible for paying this amount to TTSD under the Franchise Agreement. The remaining 398 accounts, totaling \$203,897.67 (\$219,817.67 including the \$40 per account administrative fee), are listed in Exhibit 1 of the attached Resolution.

On May 25, 2022, letters were mailed to the property owners notifying them of their delinquent account balances as well as of the intent to place their bills, plus a \$40 administrative fee, on the County Tax Roll (sample letter attached). The property owners had until June 15, 2022 to clear the delinquent accounts. However, any payments received on or before June 30, 2022 will be credited to the delinquent accounts. All cleared accounts will be removed from the property list attached to the Resolution prior to being forwarded to the Auditor's Office, and, as such, will not be assessed the \$40 administrative fee. In order to place the delinquent accounts and the associated administrative fees on the County Tax Roll, your Board must adopt the attached Resolution.

ENVIRONMENTAL IMPACT

This action does not constitute a "Project" under the California Environmental Quality Act (CEQA) pursuant to CEQA Guidelines Sections 15378(a) and (b)(5) because it is an administrative action that does not result in any change in the environment.

FISCAL IMPACT

Placement of the delinquent accounts and associated fees on the County Tax Roll will result in the County recovering up to \$203,897.67 for the unpaid bills and up to \$15,920.00 in penalties to offset the County's costs associated with calculating, collecting, and tracking unpaid bills. The uncollectable amount of \$1,600.21 is budgeted and paid for by the Solid Waste Management Enterprise Fund. The total amount to be paid to TTSD shall not exceed \$205,497.88 (\$203,897.67 delinquent accounts and \$1,600.21 uncollectable accounts). There is no impact to the General Fund.
