ACTION REQUESTED

Approve appropriation of \$2,000 in Revenue Sharing monies to Auburn Interfaith Food Closet as requested by Supervisor Gore (\$250), Supervisor Weygandt (\$250), Supervisor Holmes (\$500), and Supervisor Jones (\$1,000).

BACKGROUND

In approving the following contributions, the Placer County Board of Supervisors finds that each and every approved contribution serves a public purpose by promoting the general welfare of the county and its inhabitants, therefore a benefits results to the county.

The Board of Supervisors is being asked to approve Revenue Share funds to the Auburn Interfaith Food Closet. The Auburn Interfaith Food Closet meets an important social need within Placer County by acquiring and distributing nutritious food to families, retirees and other members of the community who are food insecure. The organization also provides personal care and hygiene items as available. Any revenue sharing contributions received will be used to offset these costs.

FISCAL IMPACT

Funding is provided for in the FY 2021-22 Community and Agency Support budget (CC10018). There is no additional impact to the general fund.

AIFC serves residents of 16 zip codes within Placer County, providing food sufficient for 12 meals (4-days) for each household member. As available, personal care and hygiene items are provided.
