ACTION REQUESTED

Approve appropriation of \$1,250 in Revenue Sharing monies to Roseville Community Crime Stoppers as requested by Supervisor Gore (\$500), Supervisor Weygandt (\$250), and Supervisor Jones (\$500).

BACKGROUND

In approving the following contributions, the Placer County Board of Supervisors finds that each and every approved contribution serves a public purpose by promoting the general welfare of the county and its inhabitants, therefore a benefit results to the county.

The Board of Supervisors is being asked to approve Revenue Share funds to Roseville Community Crime Stoppers. Roseville Community Crime Stoppers is dedicated to preventing and solving crimes through community involvement, public education, and the nurturing of positive relationships with public safety organizations in an effort to continually improve the quality of life in the community. The organization is holding its annual Run Crime out of Roseville fundraiser on the 4th of July, which provides the community with an opportunity to enjoy time together outdoors in a safe environment. Revenue Share contributions will be used to help offset the cost of the event.

FISCAL IMPACT

Funding is provided for in the FY 2021-22 Community and Agency Support budget (CC10018). There is no additional impact to the general fund.
