SUBJECT: Revenue Sharing – Seniors First

ACTION REQUESTED

Approve appropriation of \$2,000 in Revenue Sharing monies to Seniors First as requested by Supervisor Gore (\$1,000), Supervisor Weygant (\$500), and Supervisor Jones (\$500).

BACKGROUND

In approving the following contributions, the Placer County Board of Supervisors finds that each and every approved contribution serves a public purpose by promoting the general welfare of the county and its inhabitants, therefore a benefit results to the county.

The Board of Supervisors is being asked to approve Revenue Share funds to help support Seniors First, Meals on Wheels. Meals on Wheels provides three hot meals and two frozen meals as well as a safety check five days a week to seniors in Placer County who are homebound or immobile. Seniors First also provides supplemental groceries for seniors who are food insecure and need additional food. Revenue Share contributions will be used to purchase food and offset additional costs of providing meals to seniors.

FISCAL IMPACT

Funding is provided for in the FY 2021-22 Community and Agency Support budget (CC10018). There is no additional impact to the general fund.
