SUBJECT: Revenue Sharing – Sierra Senior Services

ACTION REQUESTED

Approve appropriation of \$1,250 in Revenue Sharing monies to support Sierra Senior Services, Meals on Wheels as requested by Supervisor Gore (\$250), Supervisor Jones (\$500), and Supervisor Gustafson (\$500).

BACKGROUND

In approving the following contributions, the Placer County Board of Supervisors finds that each and every approved contribution serves a public purpose by promoting the general welfare of the County and its inhabitants, therefore a benefit results to the County.

The Board of Supervisors is being asked to approve appropriations to Sierra Senior Services, Meals on Wheels. Sierra Senior Services is the Meals on Wheels provider for the eastern portion of Placer County, delivering hot nutritious meals every day to seniors who may not otherwise have food to eat. This is an unduplicated program in Eastern Placer County serving seniors who are at risk of going hungry. Revenue sharing contributions will be used to help offset the cost of food and supplies

Funding is provided for in the FY 2021-22 Community and Agency Support budget (CC10018). There is no additional impact to the general fund.
