ACTION REQUESTED

Approve appropriation of \$1,750 in Revenue Sharing monies to the North Tahoe Business Association as requested by Supervisor Jones (\$250) and Supervisor Gustafson (\$1,500).

BACKGROUND

In approving the following contributions, the Placer County Board of Supervisors finds that each and every approved contribution serves a public purpose by promoting the general welfare of the County and its inhabitants, therefore a benefit results to the County.

The Board of Supervisors is being asked to approve Revenue Share funds to Tahoe City Downtown Association. The Tahoe City Downtown Association promotes and enhances the Tahoe Community through innovation, leadership, and local events. The Association hosts community events including Independence Day celebrations. In a shift that aligns with the region's commitment to sustainability and stewardship, and addresses community concerns related to fire risk and environmental impacts, this year's 4th of July celebrations have shifted to an eco-friendly drone show alternative to fireworks. The show will take place at Commons Beach. Revenue Share contributions will be used to help offset the cost of the event.

FISCAL IMPACT

Funding is provided for in the FY 2021-22 Community and Agency Support budget (CC10018). There is no additional impact to the general fund.
