The stated purpose of the Placer County Youth Commission is to integrate youth voice into local policy making and engage the community to create positive change. The Commission is also tasked with organizing activities to help educate and motivate Placer County youth to participate in the local political process. Commissioner recommendations were made through an application and interview process conducted by a nominating committee composed of two adult advisors for the Commission and one youth mental health specialist.

PROPOSED PUBLIC COMMITTEE INFORMATION

PURPOSE: The Placer County Youth Commission integrates the youth voice into local policymaking by researching youth issues and concerns, relating their findings and positions to local policy makers, and engaging the community to create positive change. The Commission shall organize activities to help educate and motivate youth of Placer County to participate in the local political process.

CONFLICT OF INTEREST: No

COMPOSITION: The Placer County Youth Commission will consist of twenty (20) primary members* who shall be youth between 14-18 years of age, or in 9th-12th grade except that a youth that has not reached the age of 14 but is entering the 9th grade may be appointed. There shall be at least two (2) members from each supervisory district. An individual may sit for a maximum of two one-year terms.

MEETINGS: Orientation held in August. August through June two evening meetings a month held generally:

1st Wednesday of each month from 6:30-8:00 p.m. in Auburn Public Library,

3rd Wednesday of each month from 6:30-8:00 p.m. generally in the Rocklin Public Library.

COMPENSATION: All members of this commission shall serve without compensation.
