ACTION REQUESTED

Approve appropriation of \$2,500.00 in Revenue Sharing monies to the Boys & Girls Club of Placer County, Chillin' & Grillin' event as requested by Supervisor Gore (\$500.00), Supervisor Weygandt (\$500.00), Supervisor Holmes (\$500.00), Supervisor Jones (\$500.00), and Supervisor Gustafson (\$500.00).

BACKGROUND

In approving the following contributions, the Placer County Board of Supervisors finds that each and every approved contribution serves a public purpose by promoting the general welfare of the County and its inhabitants, therefore a benefit results to the County.

The Board of Supervisors is being asked to approve appropriations to help support the Boys and Girls Club of Placer County. For over 20 years the Boys and Girls Club of Placer County has been helping to support local youth through education, character development, career exploration, sports and recreation, the arts and community service activities during the school year and summer vacation. The Club provides positive programs and activities to boys and girls from 6 to 18 years of age, helping them to become productive, self-sufficient individuals. The Chillin' & Grillin' event is the biggest fundraiser of the year for the Club. Proceeds from the event go directly to support Club programs and services that promote youth development strategy by instilling a sense of competence, usefulness, belonging and influence. Revenue Share contributions will be used to help offset the cost of the event.

The total cost of this contribution is \$2,500.00. Funding for this contribution is available in the FY 2022-23 budget for CC10018 - Community and Agency Support. There is no additional impact to the general fund.
