ACTION REQUESTED

Approve appropriation of \$1,750.00 in Revenue Sharing monies to Lincoln Area Chamber of Commerce, Taste of Lincoln Showcase as requested by Supervisor Weygandt (\$1,500.00), and Supervisor Jones (\$250.00).

BACKGROUND

In approving the following contributions, the Placer County Board of Supervisors finds that each and every approved contribution serves a public purpose by promoting the general welfare of the County and its inhabitants, therefore a benefit results to the County.
