ACTION REQUESTED

Approve appropriation of \$1,250.00 in Revenue Sharing monies to Auburn Chamber of Commerce, State of the Community Dinner as requested by Supervisor Holmes (\$500.00), Supervisor Jones (\$250.00), and Supervisor Gustafson (\$500.00).

BACKGROUND

In approving the following contributions, the Placer County Board of Supervisors finds that each and every approved contribution serves a public purpose by promoting the general welfare of the County and its inhabitants, therefore a benefit results to the County.

The Board of Supervisors is being asked to approve appropriations to the Auburn Chamber of Commerce for the State of the Community Dinner.
