ACTION REQUESTED

Approve appropriation of \$1,750.00 in Revenue Sharing monies to Child Advocates of Placer County, 2022 Fall Gala as requested by Supervisor Gore (\$250.00), Supervisor Weygandt (\$500.00), Supervisor Holmes (\$250.00), Supervisor Jones (\$500.00), and Supervisor Gustafson (\$250.00).

BACKGROUND

In approving the following contributions, the Placer County Board of Supervisors finds that each and every approved contribution serves a public purpose by promoting the general welfare of the County and its inhabitants, therefore a benefit results to the County.

The Board of Supervisors is being asked to approve appropriations to Child Advocates of Placer County for their 2022 Fall Gala. The mission of the organization is to be the bridge between the most vulnerable in the community and volunteers who make a difference. The organization's Court Appointed Special Advocate (CASA) Program serves foster youth, juvenile justice youth, and youth involved in Commercial Sexual Exploitation (CSE). Family Service Programs serve the parents of these youth as well as other low-income families. Child Advocates of Placer County serves approximately 500 children and families each year. The organization holds fund raising events, such as the annual Fall Gala, which raises funds to allow the organization to continue their mission of services. Sponsorships and ticket sales cover the cost of the event. Revenue Share contributions will be used to help further the Youth and Family Services programs.

FISCAL IMPACT

The total cost of this action is \$1,750.00. Funding is provided for in the FY 2022-23 Community and Agency Support budget (CC10018). There is no additional impact to the general fund.
