**ACTION REQUESTED**

Approve appropriation of \$2,500.00 in Revenue Sharing monies to Granite Wellness Centers as requested by Supervisor Gore (\$250.00), Supervisor Weygandt (\$250.00), Supervisor Holmes (\$500.00), Supervisor Jones (\$1,000.00), and Supervisor Gustafson (\$500.00).

**BACKGROUND**

In approving the following contributions, the Placer County Board of Supervisors finds that each and every approved contribution serves a public purpose by promoting the general welfare of the County and its inhabitants, therefore a benefit results to the County.

The Board of Supervisors is being asked to approve appropriations to Granite Wellness Centers Foundation, Ed Bonner Golf Classic. Granite Wellness Centers provide an array of services to address substance use disorders and related behavioral health issues. The focus of the organization is on long term individual and family recovery, helping people become contributing members of their community and helping to build solid family foundations. The Ed Bonner Golf Classic is one of the Foundation's main annual fundraisers. The event raises funds to help the organizations work to help teens, families, parents and individuals find safety, health, and rebuild their lives. Revenue share contributions will be used to help offset the cost of the event and provide continued support of adolescent prevention and intervention programs.

**FISCAL IMPACT**

The total cost of this action is \$2,500.00. Funding is provided for in the FY 2022-23 Community and Agency Support budget (CC10018). There is no additional impact to the general fund.

Granite Wellness Centers (GWC) is a non-profit community benefit organization, whose mission is to promote wellness and quality of life. Established in 1974, GWC has evolved and expanded to address community needs and serves thousands of clients and their families on a regular basis. Granite Wellness Centers provides an array of integrated, individual and family-centered services to address substance use disorders and related behavioral health issues, focused on outcomes of long-term individual and family recovery, contributive citizenship, and family functioning. Services include outpatient counseling (adults and adolescents), education classes (including DUI), withdrawal management and residential treatment, recovery residence housing, child development programs, and ancillary services including anger management, parenting classes, and children's programs. Utilizing a continuum of care, we engage individuals at the earliest signs of problems (schools, DUI and drug diversion) and integrate them into our more detailed services as assessed and needed. We work closely with county and court personnel

to ensure all those needing services are easily brought in to our programs.

The Ed Bonner Golf Classic is one of our Foundation's main annual fundraisers that includes a fun-filled day of golf, including a putting contest, raffle and tee prizes in support of Granite Wellness Centers' work to help teens, families, parents, and individuals find safety, health, and rebuild their lives as they heal from substance use disorders and associated behavioral health issues.
