SUBJECT: Revenue Sharing - Lincoln Rotary Club Foundation, Tour de Lincoln Event

ACTION REQUESTED

Approve appropriation of \$2,100.00 in Revenue Sharing monies to the Lincoln Rotary Club Foundation as requested by Supervisor Weygandt (\$2,000.00) and Supervisor Jones (\$100.00).

BACKGROUND

In approving the following contributions, the Placer County Board of Supervisors finds that each and every approved contribution serves a public purpose by promoting the general welfare of the County and its inhabitants, therefore a benefit results to the County.

The Board of Supervisors is being asked to approve an appropriation to the Lincoln Rotary Club Foundation for their 20th annual Tour de Lincoln fundraising event. This event offers cyclists a day of cycling after selecting one of three scenic courses on back roads of Lincoln and South Placer County. This event has historically attracted visitors from Northern California and Nevada, generating revenue for local hotels and eateries. The proceeds from this event will be used to address food insecurity and will assist the local food closet in purchasing and distributing food to community members in need. Revenue Share contributions will be used to help offset the cost of the fundraising event.

FISCAL IMPACT

The total cost of this action is \$2,100.00. Funding for this contribution is available in the FY2022-23 budget for CC10018 - Community and Agency Support. There is no additional impact to the General Fund.
