SUBJECT: Revenue Sharing – Loomis Basin Chamber of Commerce, Eggplant Festival

ACTION REQUESTED

Approve appropriation of \$1,450.00 in Revenue Sharing monies to Loomis Basin Chamber of Commerce as requested by Supervisor Gore (\$200.00), Supervisor Holmes (\$1,000.00), and Supervisor Jones (\$250.00).

BACKGROUND

In approving the following contributions, the Placer County Board of Supervisors finds that each and every approved contribution serves a public purpose by promoting the general welfare of the County and its inhabitants, therefore a benefit results to the County.

The Board of Supervisors is being asked to approve an appropriation to help support the Loomis Basin Chamber of Commerce’s annual Loomis Eggplant Festival, which highlights the town’s agricultural roots and draws a crowd of more than 10,000 visitors. The Loomis Eggplant Festival features entertainment on three stages as well as booths offering gourmet and festival food, kid-friendly activities, arts and crafts and cooking demonstrations, all hosted by community organizations and local businesses. Revenue Share funds will be used to help offset the cost of the event.

FISCAL IMPACT

The total cost of this action is \$1,450.00. Funding for this contribution is available in the FY 2022-23 budget for CC10018 - Community and Agency Support. There is no additional impact to the general fund.
