ACTION REQUESTED

Approve appropriation of \$2,500.00 in Revenue Sharing monies to Placer County Law Enforcement Chaplaincy, 10th Annual Back the Badge BBQ Fundraiser as requested by Supervisor Gore (\$500.00), Supervisor Weygandt (\$500.00), Supervisor Holmes (\$500.00), Supervisor Jones (\$500.00) and Supervisor Gustafson (\$500.00).

BACKGROUND

In approving the following contributions, the Placer County Board of Supervisors finds that each and every approved contribution serves a public purpose by promoting the general welfare of the County and its inhabitants, therefore a benefit results to the County.

The Board of Supervisors is being asked to approve appropriations to Placer County Law Enforcement Chaplaincy (PCLEC) for their 10th Annual Back the Badge BBQ Fundraiser. PCLEC is a field service ministry that offers a source of strength, compassion, and counsel to law enforcement officers, their families, crisis victims, first responder personnel and the citizens of Placer County. The organization's 10th Annual Back the Badge BBQ Fundraiser will be held at the Blue Goose Event Center and will offer a raffle, silent auction, music, games and more. Revenue sharing contributions will be used to help offset the cost of the event.
