ACTION REQUESTED

Approve appropriation of \$750.00 in Revenue Sharing monies to Placer Nature Center, 30th Anniversary Fundraiser as requested by Supervisor Gore (\$200.00), Supervisor Jones (\$250.00), and Supervisor Gustafson (\$300.00).

BACKGROUND

In approving the following contributions, the Placer County Board of Supervisors finds that each and every approved contribution serves a public purpose by promoting the general welfare of the County and its inhabitants, therefore a benefit results to the County.

The Board of Supervisors is being asked to approve appropriations to the Placer Nature Center, 30th Anniversary Fundraiser. The Placer Nature Center delivers community-based volunteer-supported environmental education programs to children, families, schools and community groups. Placer Nature Center will celebrate their 30th Anniversary with a community event and fundraiser on October 22, 2022. The event will include educational workshops, nature games, raffles, auction, food and music. The event serves as both a fundraiser and a community awareness event. Revenue share contributions will be used to help offset the cost of the event.

FISCAL IMPACT

The total cost of this action is \$750.00. Funding for this contribution is available in the FY 2022-23 budget for CC10018 – Community and Agency Support. There is no additional impact to the general fund.
