**ACTION REQUESTED**

1. Approve an amendment to the revenue agreement with Anthem Blue Cross related to Enhanced Care Management and Community Supports services to amend the services provided from January 1, 2022, through December 31, 2022, and authorize the Director of Health and Human Services to sign the amendment with Risk Management and County Counsel concurrence, to sign subsequent amendments consistent with the agreement's subject matter and scope of work with Risk Management and County Counsel concurrence, and approve automatic renewal for consecutive one (1) year periods unless otherwise terminated.
2. Authorize the Director of Health and Human Services, or Designee, to sign subsequent amendments consistent with the agreement's subject matter and scope of work with Risk Management and County Counsel concurrence for the revenue agreement with Health Net of California to provide Enhanced Care Management services to populations of focus for reimbursement to Placer County Health and Human Services in accordance with established rates from January 1, 2022, through December 31, 2022, and approve automatic renewal for consecutive one (1) year periods unless otherwise terminated.
3. Authorize the Director of Health and Human Services, or Designee, to sign subsequent amendments consistent with the agreement's subject matter and scope of work with Risk Management and County Counsel concurrence for the revenue agreement with Health Net of California to provide covered Community Supports to populations of focus for reimbursement to Placer County Health and Human Services from January 1, 2022, through December 31, 2022, and authorize the Director of Health and Human Services to sign the agreement with Risk Management and County Counsel concurrence and approve automatic renewal for consecutive one (1) year periods unless otherwise terminated.

**BACKGROUND**

The California Department of Health Care Services (DHCS) has a new framework for a broader delivery system, program, and payment reform across the Medi-Cal program called California Advancing and Innovating Medi-Cal (CalAIM). CalAIM leverages Medicaid as a tool to help address many of the complex challenges facing the most vulnerable members of society, such as homelessness, insufficient behavioral health care access, those with complex medical

conditions, and the growing aging population. On January 25, 2022, your Board approved the Director of Health and Human Services to enter into agreements with Anthem and Health Net to provide ECM and CS through the Placer County Adult System of Care. At that time, the Department did not seek amendment authority for these agreements, but it is requesting it now for the amendment with Anthem and future amendments for both Anthem and Health Net moving forward.

DHCS continues to implement Enhanced Care Management (ECM) and Community Supports (CS) programs to expand services to vulnerable populations. These services address clinical and non-clinical needs of high-cost and high need beneficiaries through a collaborative and interdisciplinary approach to providing intensive care and comprehensive care services to improve health and improve social determinants of health. The State of California is contracting with Managed Care Plans to establish the ECM and CS provider network for Medi-Cal enrollees. In Placer County two managed care plans, Health Net of California (Health Net) and Anthem Blue Cross (Anthem) will administer ECM and CS systems.

Placer County staff have provided Enhanced Care Management and three Community Supports (Housing Transition Navigation, Housing Deposits, and Housing Tenancy and Sustaining Services) while the Medical Respite services were subcontracted to The Gathering Inn (TGI).

After the prior agreement was approved, TGI entered into direct contracts for Medical Respite Services with the Managed Care Plans so the subcontract through Placer County was no longer needed and is therefore being removed from the original contract. Medical Respite services will still be provided in Placer County, so this amendment does not impact service delivery.

#### **FISCAL IMPACT**

The revenue for this agreement is available in the FY 2022-23 budget for CC14001--Adult System of Care. There is no additional impact to the General Fund.
