WHEREAS, the Political Reform Act requires local government agencies to maintain a conflict of interest code; and

WHEREAS, pursuant to Government Code Section 82011, the Placer County Board of Supervisors is the "code reviewing body" for local agencies, except cities, located wholly within the boundaries of Placer County; and

WHEREAS, Government Code Section 87306.5 requires that, in even-numbered years, such local agencies report to the Board on the status of their conflict of interest codes; and

WHEREAS, any amended local agency conflict of interest codes will only take effect upon the Board's approval; and

WHEREAS, the Board has reviewed the local agency codes and concluded that their codes either: (1) are legally adequate, noted as "currently adequate" in Exhibit A; or (2) will be legally adequate

with minor revisions, noted as "adequate with revisions" in Exhibit A; or (3) are currently under review and amendment by their respective governing boards, noted as "under review" in Exhibit A.

NOW, THEREFORE, BE IT RESOLVED that the Board of Supervisors of the County of Placer, State of California acknowledges receipt of and (1) hereby approves those codes described as "currently adequate" in Exhibit A; and (2) hereby revises and approves as revised those codes described as "adequate with revisions" in Exhibit A.

BE IT FURTHER RESOLVED that this Resolution shall take immediate effect.
