ACTION REQUESTED

1. Approve the appointment Mike Gardner to seat #4 representing District 5 of the North Auburn-Ophir Fire Safe Council.

BACKGROUND

The purpose of the North Auburn-Ophir Fire Safe Council is to educate the public regarding the dangers associated with living in a Wildland Urban Interface Area as well as to assist in identifying high-risk areas, to provide a Community Fire Safe Plan for those areas covered by the Council, to cooperate with all related public and governmental agencies to implement the plan, and to promote fuel reduction programs and projects which will provide a safer environment in the event of wildfires which may threaten the area.

The North Auburn-Ophir Fire Safe Council consists of five members, appointed by the Board of Supervisors, each serving 2-year terms. Members must reside in or own a business within the Fire Safe Council Area. Meetings are held on the fourth Monday of each month at 4:00pm at Placer County Office of Emergency Services, 2968 Richardson Drive, Auburn, CA 95603.
