WHEREAS, pursuant to the authority granted to the Board of Supervisors in California Vehicle Code Sections 40203.5(a) for the establishment of a schedule of penalties for parking and related violations, late payment penalties, administrative fees and other related charges for parking and related violations under the California Vehicle Code, Placer County Code, or under any federal statute or regulation, the Board of Supervisors may establish a fine schedule by resolution, and

WHEREAS, Article 10.12, Parking, has been amended to remove references to previous fine amounts for certain parking violations and references have instead been added to reference this Parking Fine Schedule, and

WHEREAS, the effective date of this Parking Fine Schedule is intended to be the same date that the amendments to Article 10.12, Parking, go into effect, which is 30 days after the Board of Supervisors has approved the ordinance and that hearing date is October 31, 2023, and

WHEREAS, the Parking Fine Schedule includes escalating penalty amounts for first, second, third, and subsequent violations of each offense, and

WHEREAS, the Parking Fine Schedule is attached as "Exhibit 1."

NOW, THEREFORE, BE IT RESOLVED by the Board of Supervisors of the County of Placer, State of California, that the Parking Fine Schedule is hereby established with an effective date of November 30, 2023.
