Community Food Producer/Gleaner Registration Form

New Rule changes allow a Community Food Producers or Gleaners to sell or provide whole uncut fruits or vegetables, and unrefrigerated shell eggs (*maximum 15 dozen per month*), directly to the public, to a permitted restaurant, or to a cottage food operation without a permit if registered. **Complete this form and send to Environmental Health at address below.**

NOTE: Community Food Producers and Gleaners are required to register with the local Environmental Health office. Egg sales registration is also required with the California Department of Food and Agriculture 1220 N Street Sacramento, California 916-654-0466
