COMPOSITION: Composed of members (usually the Post Service Officer) designated by each post, camp or barracks of each recognized veterans organization; plus the County Veterans Service Officer who serves as Council secretary but not a Council member. Members serve 1 year terms with terms ending Aug 31 of each year (Res. 86-347), or until their successors have been designated and appointed as provided above (County Code Section 2.710).

MEETINGS: Second Thursday of each month, at 6:00 p.m. at various locations within the County (announced by Council Agenda).

COMPENSATION: Members receive \$30 per diem per meeting plus a mileage allowance.
