SUBJECT: Appoint Members in Lieu of Election to the Democratic Central Committee, Republican Central Committee, and Green Party County Council

RECOMMENDATION

Approve the attached resolution appointing in lieu of election the individuals who completed the Central Committee and County Council candidate filing process for the Democratic Central Committee, Republican Central Committee, and Green Party County Council.

BACKGROUND

California Elections Code Sections 7228, 7423, and 7772.1 provides for the appointment of Democratic Central Committee Members, Republican Central Committee Members, and Green Party County Council Members in lieu of election if by 5:00 PM on the 88th day prior to the election, the number of nominees does not exceed the number of offices to be filled at that election and no petition for a write-in campaign signed by 25 registered voters affiliated with the political party involved has been presented to the Elections Division.

The Democratic Central Committee, Fourth (4th) and Fifth (5th) Supervisorial Districts, Republican Central Committee, First (1st), Third (3rd), Fourth (4th) and Fifth (5th) Supervisorial Districts, and Green Party County Council were scheduled to have their central committee and county council elections on June 6, 2006. Having an insufficient number of candidates to force an election in the districts and receiving no such petition in the districts by March 30, 2006, the elections have been cancelled and your Board must appoint the nominees to terms in these districts as specified in Exhibit A.

FISCAL IMPACT

There is no fiscal impact to the county by approving this request.

WHEREAS, Election Code Sections 7228, 7423, and 7772.1 provide for the appointment of members to the Democratic Central Committee, Republican Central Committee, and Green Party County Council if the number of candidates nominated does not exceed the number to be elected, and no petition for a write-in campaign is signed by 25 registered voters affiliated with the political party involved, within the time specified by law; and

WHEREAS, the number of nominees for positions on the Democratic Central Committee, Fourth (4th) and Fifth (5th) Supervisorial Districts, Republican Central Committee, First (1st), Third (3rd), Fourth (4th) and Fifth (5th) Supervisorial Districts, and Green Party County Council did not exceed the number of vacancies, and no petitions for write-in campaigns were submitted to the Placer County Clerk-Recorder-Registrar of Voters; and

WHEREAS, the Placer County Elections Division verified these facts by conducting election services for the Democratic Central Committee, Republican Central Committee and Green Party County Council; and

WHEREAS, the nominees for the Democratic Central Committee, Fourth (4th) and Fifth (5th) Supervisorial Districts, Republican Central Committee, First (1st), Third (3rd), Fourth (4th) and Fifth (5th) Supervisorial Districts, and Green Party County Council are listed, and attached hereto, in Exhibit A;

NOW, THEREFORE, BE IT RESOLVED, that the Placer County Board of Supervisors approves the appointment in lieu of election of the nominees listed in Exhibit A to the Democratic Central Committee, Fourth (4th) and Fifth (5th) Supervisorial Districts, Republican Central Committee, First (1st), Third (3rd), Fourth (4th) and Fifth (5th) Supervisorial Districts, and Green Party County Council; and

BE IT FURTHER RESOLVED, that the oath of office shall be administered to the newly appointed Democratic Central Committee, Fourth (4th) and Fifth (5th) Supervisorial Districts, Republican Central Committee, First (1st), Third (3rd), Fourth (4th) and Fifth (5th) Supervisorial Districts, and Green Party County Council Members who shall, when qualified, take office and serve exactly as if elected at a Primary Election.
